Thanks for sending this through. I've reviewed and found the information to be useful and informative whilst using correct terminology that educates.

My only note would be referring to trans people as 'gender diverse', it's something I have begun to notice a lot with health related organisations and not sure where it's come from. Gender diversity as a description for diversity regarding gender is correct usage, but I'd recommend not referring to a trans person singularly as a gender diverse person, a binary trans person may not consider their gender diverse at all and just want to be referred to as a man or woman.

I hope this makes sense, I know it's just a small note on semantics but one that can make a huge difference to someone.
