4. What is your budget for simulation training in the current financial year?

HEIW's current financial year runs from the 1st April 2021 to 31st March 2022. As there is no specific budget allocation for simulation training we are unable to provide this information.

5. How does HEIW assess suppliers of simulation training to ensure value for money?

To ensure compliant contracts, ensuring value for money, we investigate suitable routes to market e.g. existing framework that HEIW as an NHS Educational Body can access or advertising opportunities via Sell2Wales either below or above Public Contract Regulation (PCR2015) value. To assess suppliers we follow the framework guidance and when going out to an open competition we use the Most Economically Advantageous Tender (MEAT) assessment by considering qualitative, technical, and commercial criteria. If suppliers are interested in opportunities to contract with HEIW we recommend that they register on Sell2Wales to see open opportunities or tender for relevant frameworks opportunities.
