HEIW Responsibility

Stage 1 - Performers List application received by BSA Performers List

NHS Wales Shared Services
Partnership (NHSWSSP) carries out all
necessary Performers List checks to
determine if appropriate to PLVE
process or not

NHSWSSP informs the Local Health Board (LHB) and HEIW that applicant is required to demonstrate PLVE Performers List Application Form DPL1 Form

LHB ensures that a practice has been identified and that there are no outstanding issues and informs HEIW Office

Stage 2 – PLVE Requirements Assessment

Dentist submits a PLVE Application.
Forms and guidance notes are
available to download from HEIW

HEIW checks that proposed Mentor and placement practice meet its criteria for appointment
HEIW reviews RCE and application information and decides on approval or otherwise
If approved, HEIW sets educational requirements and informs Applicant and Mentor

HEIW Responsibility

Stage 3 – Entry onto Performers List

NHSWSSP adds applicant onto Performers List, with the requirement that the applicant needs to complete PLVE HEIW contacts LHB (and its agent if appropriate) and if approved for PLVE, informs them that the practice and Mentor have been approved and also the duration of the PLVE review period



NHSWSSP sends email to HEIW Office informing that the applicant has been placed on the Performers List



Stage 4 – Applicant formally enters PLVE process

HEIW manages PLVE arrangements in accordance with its local processes

Practice Mentor carries out communications DOPS and clinical DOPS within first two weeks and reports to HEIW Office

Applicant carries out requirements set out in approved and agreed

Action Plan

Applicant submits portfolio of evidence for review (to timescale set by HEIW Office)

If evidence not complete, HEIW informs applicant of outstanding requirements (and extends review period if necessary)

Stage 5 Review of Performers List Status

LHB and HEIW receives notification of completion certificate issue and reviews applicant's Performer List status

If evidence complete, applicant completes HEIW PLVE questionnaire.

 HEIW informs applicant and NHSWSSP of completion and issues Certificate of Demonstration to applicant.



Applicant's Performers List Conditions are removed by LHB and NHSWSSP and it's agent is informed if necessary

APPLICANT FORMALLY LEAVES PLVE PROCESS
