

Wales Deanery Privacy Notice for WDTFT Educational Supervisors

This privacy notice is intended to provide transparency regarding what personal data the Wales Deanery will collect about you, how it will be processed and stored, how long it will be retained and who will have access to your data.

The Wales Deanery is a data controller in respect of the personal data it holds concerning Educational Supervisors in Wales.

Personal data is information from which an individual can be identified either directly or indirectly when the information is read in conjunction with other data that a data controller holds.

From 25 May 2018 the Data Protection Act 1998 will be replaced by the General Data Protection Regulation and this will be the principal piece of UK legislation concerning personal data. The Wales Deanery will be subject to the General Data Protection Regulation.

WDTFT Educational Supervisors should be aware that this privacy notice applies to all the processing of your personal data by the Wales Deanery in relation to or arising from your role.

Why your personal data is collected

Your personal data is collected and held for the purposes of:

- Supporting the management of training programmes – Your data will be used to determine outputs from programmes and to inform the number of Educational Supervisors required for the programme in the future.
- Managing your recognition as an Educational Supervisor – Personal data collected for this purpose will be kept in a database, which will usually contain your name, employing Health Board/Trust, General Dental Council (GDC) number, e-mail address and any other information pertinent to the effective management of your Educational Supervisor role.
- Quality Assurance and performance review processes – Your data may be used to support various local mechanisms including practice visits.
- To work collaboratively with stakeholders to achieve improvements and developments for WDTF Training and the Dental workforce in Wales.
- Maintaining patient safety through the management of performance concerns – Your personal details may be shared with the GDC should there be significant concerns regarding your fitness to practice as an Educational Supervisor.
- To communicate with you about development opportunities, events, surveys, and information that may be of interest to you in your Educational Supervisor role.
- To facilitate a transparent approach to WDTF Training in Wales.
- To ensure the professional integrity of our WDTF training providers: for example no criminal records.
- Safeguarding information.

The functions of the Wales Deanery are carried out in the public interest. The processing of Educational Supervisors personal data is necessary for the purposes of those functions. Sensitive personal data that we may need to share includes information relating to your health or criminal record should your employer or the GDC need to be made aware.

How your personal data is collected

Personal data is collected when you submit your WDTF Training Educational Supervisor application form, sign and when you submit your Contract.

How your personal data is kept secure

Access to your personal data is restricted to the WDTF TPD and Administrator within the Wales Deanery.

Your personal data will be retained for six years after you have left your Educational Supervisor role, at which point your personal data will be confidentially and securely destroyed.

How and why your personal data may be shared

This information is kept in a hidden electronic database with limited access.

Your personal data may be shared with- –

- Welsh Government
- Local Health Boards (LHBs)
- Third parties for reporting or research purposes and management of services such as portfolios

The Wales Deanery will only transfer your personal data to third parties using secure channels and where it is needed to manage your Educational Supervisor role, for example issues with performance and professional registration and integrity or issues relating to payments.

The Wales Deanery will not transfer your data unless it is satisfied of the following matters:

1. That there is a fair and lawful basis to share your personal data with the third party.
2. The data will be handled by the third party in accordance with the law on data protection.

Where the data is used for analysis and publication by a recipient or third party, any publication will be on an anonymous and aggregated basis, and will not make it possible to identify any individual. This will mean that the data ceases to become personal data.

Third parties may include the following non-exhaustive list: British Dental Association (BDA), Welsh Government, GDC

Your rights and responsibilities

It is important that you work with us to ensure that the information we hold about you is accurate and up to date so please inform the Wales Deanery immediately if any of your personal data needs to be updated or corrected.

All communications from the Wales Deanery will normally be by email. It is therefore essential for you to maintain an effective and secure email address or you may not receive information.

If at any point you wish to gain a copy of your personal data that is held by the Wales Deanery you may submit a subject access request in writing.

In certain limited circumstances, you have a right to object to processing that is likely to cause you damage or distress, or to any decisions made by automated means that significantly affect you.

You also have a right to have inaccurate personal data rectified, blocked, erased or destroyed.

If you wish to exercise any of these rights or have any concerns in relation to how your personal data is processed, please contact the Wales Deanery.
